Thank you for your interest in Foodies Anonymous Catering!

With growing concern of interruption due to the global pandemic, we have outlined our COVID-19 cancellation policy to make you feel more comfortable planning your future event. Please note that throughout this document;

- FOODIES will refer to 2499279 Ontario Inc. O/A Foodies Anonymous Catering,
- CLIENT will refer to you - the undersigned,
- EVENT will refer to all elements of the event order previously agreed upon by the CLIENT and FOODIES.
- DEPOSIT will refer to any and all monies made payable to FOODIES by the CLIENT or associated parties for payment toward the EVENT

In the event that the CLIENT is unable to host the EVENT on the agreed date as a result of restrictions put in place due to COVID-19 (Federal, Provincial or Municipal), FOODIES is prepared to offer the following options with respect to your deposit.

1. Reschedule

- The CLIENT will be given the opportunity to reschedule the EVENT within one calendar year of the original date of the EVENT.
- The CLIENT will have 30 days from the original date of the EVENT to notify FOODIES of a reschedule date, otherwise your requested date will be subject to availability.
- Please note: in the event of rescheduling, the grand total of your EVENT is subject to increase based on market fluctuations.



2. Reduction in Guest Count

- In the event that government restrictions dictate that your guest count cannot exceed a number less than originally quoted, FOODIES will amend the total value of the EVENT if notified more than 14 days prior to the EVENT
- If notified within 14 days of EVENT, total value is subject to payment in full

2. Credit for future purchases

- In the event that your EVENT cannot be rescheduled, the CLIENT's deposit will be made available to use as a credit toward future event bookings, gifts, meal packages etc.
- Please note: the DEPOSIT will be held and can be used up to one calendar year from the original date of the EVENT

3. Cancellation

- In the event that the EVENT is fully cancelled and the CLIENT does not wish to use the DEPOSIT for future credit, a full or partial refund will be offered.
- If the EVENT is cancelled within 14 days of the original date of the EVENT, the DEPOSIT is subject to deductions. **Please see below for guideline**



**** Deposit Guideline ****

For ALL of the above mentioned scenarios, cancellation, recution or postponement less than 14 days prior to the EVENT, the DEPOSIT is subject to deductions based on costs incurred by FOODIES on behalf of the CLIENT. FOODIES will conduct an audit on a case-by-case basis to calculate costs. These costs may include, but are not limited to:

- Third-party rental agreements
- Purchases of goods and services made by FOODIES on behalf of the CLIENT for the EVENT
- Sub-Contract agreements in which FOODIES is held liable for payment on behalf of CLIENT for the EVENT.
